# 10-Year Labour WARRANTY

This warranty is extended to the original single family homeowner identified in this warranty certificate (“Certificate”) by **Magic Window**. Subject to the terms and conditions put forth in this certificate **Magic Window** makes the following warranties to the original single family homeowner regarding labour to replace and install **Magic Window** products, or the insulated glass portion of the product.

If an **Magic Window** product or the insulated glass and working parts portion of the product should fail within a period of **10 years** from the date of purchase, **Magic Window** will replace the defective product and install the replacement product at no charge.

This warranty is limited to the furnishing of labour to replace **Magic Window** products or the insulated glass panel portion of the product and does not cover or include the cost of the product or the cost of the insulated glass panel portion of the product. Additionally, this warranty does not cover damages resulting from fire, flood, earthquake, lightning, ice, windstorms, hail or other acts of God. This warranty is not applicable for products installed in non-owner multi-family occupied dwellings or used for commercial purposes such as schools, churches, government owned structures, office buildings, etc.

The warranties put forth in this certificate are the only express warranties extended by **Magic Window** in connection with labour. The remedies set forth in this certificate shall constitute the original homeowner’s exclusive remedies, and **Magic Window** shall not be liable to the homeowner for incidental or consequential damages for the breach of any express or implied warranties in connection with the insulated glass panel or windows. This limited warranty may not be changed or modified by any representative of the manufacturer or its distributors or dealers.

## **WARRANTY TRANSFER AND CLAIMS**

This warranty is transferable one time only by the original single family homeowner to a successor owner of the property subject to the terms and conditions stated on the front of this warranty under *“Transfer of Warranty”*.
